

ORDINANCE 2012-14

AN ORDINANCE PROVIDING FOR ADJUSTMENTS OF THE ANNUAL BUDGET FOR THE FISCAL YEAR 2012 AND RATIFYING THE TRANSFER OF MONIES WITHIN THE SEWER FUND FROM ACCOUNT 5201-549-590 (CAPITAL OUTLAY) TO ACCOUNT 5201-549-190-1008 (SALARY-PLANT OPERATOR 50%).

WHEREAS, on March 19, 2012 Council adopted Resolution No. 05-2012 approving the municipal budget for fiscal year beginning January 1, 2012 and ending December 31, 2012; and

WHEREAS, the Village of Commercial Point processes 50% of the payroll for the Sewer Plant Operators from the Sewer Fund Salary-Plant Operator 50% Account (5201-549-190-1008); and

WHEREAS, monies appropriated to the Sewer Fund Salary-Plant Operator 50% Account (5201-549-190-1008) are less than what is needed for the remaining yearly payroll expenditures; and

WHEREAS, monies were transferred from the Sewer Fund Capital Outlay Account (5201-549-590) to the Sewer Fund Salary-Plant Operator 50% Account (5201-549-190-1008) on October 16, 2012 to cover payroll expenditures; and

WHEREAS, Council desires to adjust the annual budget for fiscal year 2012 and to ratify the October 16, 2012 transfer of monies to the Sewer Fund Salary-Plant Operator 50% Account (5201-549-190-1008).

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

Section 1. Monies in the amount of Two Thousand Five Hundred Dollars (\$2,500.00) and transferred on October 16, 2012 within the Sewer Fund of the Village of Commercial Point from Account Number 5201-549-590 (Capital Outlay) to Account Number 5201-549-190-1008 (Salary-Plant Operator 50%) are hereby ratified.

Section 2. This Ordinance shall take effect immediately upon passage.
