

Resolution 16-2011

A RESOLUTION TO CREATE A SALARY – POLICE SERGEANT FUND 1000-110-190-1002 AND RATIFY THE REALIGNMENT OF MONIES WITHIN THE GENERAL FUND FROM THE SALARY- POLICE CHIEF FUND 1000-110-190 AND TRANSFER IT TO THE SALARY – POLICE SERGEANT FUND 1000-110-190-1002.

WHEREAS, Council has created a new part-time police position within the Village of Commercial Point; and

WHEREAS, an additional fund must be created and monies appropriated within the General Fund to compensate the new part-time police position; and

WHEREAS, Council is authorized to create, appropriate, and transfer funds within the General Fund of the Village of Commercial Point; and

WHEREAS, on July 14, 2011 the Fiscal Officer created an additional fund and transferred monies within the General Fund to pay the new part-time police officer; and

WHEREAS, Council hereby ratifies the actions of the Village Fiscal Officer.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. Council hereby ratifies the action taken by the Village Fiscal Officer on July 14, 2011 as further set forth in Section 2 below.

Section 2. The new fund Salary – Police Sergeant 1000-110-190-1002 be created and \$10,000.00 transferred from Salary – Police Chief Fund 1000-110-190 to Salary – Police Sergeant Fund 1000-110-190-1002.

Section 3. This Resolution shall take effect and be in force from and after the earliest date allowed by law.
