

Resolution 18-2013

A RESOLUTION ADOPTING THE PICKAWAY COUNTY NATURAL HAZARD MITIGATION PLAN.

WHEREAS, the Federal Emergency Management Agency (FEMA) has established rules and regulations under 44 CFR Parts 201.6, which requires that:

“For disasters declared after November 1, 2013, a local government must have a mitigation plan approved pursuant to this section in order to receive HMGP projects grants” and

WHEREAS, the Pickaway County Emergency Management Agency has received a grant from FEMA to prepare such a mitigation plan entitled the “Natural Hazard Mitigation Plan – Pickaway County, Ohio” (HMP); and a copy of the draft HMP has been placed on the Pickaway County EMA website at www.pickaway.org; and

WHEREAS, In addition, it is understood that :

“For multi-jurisdictional plans, there must be identifiable action items specified to the jurisdiction requesting FEMA approval or credit of the plan”; and

WHEREAS, the FEMA regulation 201.6 requires:

“Documentation that the plan has been formally adopted by the governing body of the jurisdiction requesting approval of the plan (e.g. City of Village Council, County Commissioners, Tribal Council). For multi-jurisdictional plans, each jurisdiction requesting approval of the plan must document that it has been formally adopted”; and

WHEREAS, the Village of Commercial Point has reviewed the draft “Pickaway County Natural Hazard Mitigation Plan”; and

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. That the Council of Commercial Point does hereby adopt the “Natural Hazard Mitigation Plan for Pickaway County”; and

Section 2. Be it further resolved that the Pickaway County Emergency Management Agency prepare and submit to the Federal Emergency Management Agency in accordance with the draft rules and regulations published by FEMA, the Pickaway County Natural Hazard Mitigation Plan; and

Section 3. Be it further resolved that the Fiscal Officer be and hereby is authorized and directed to certify copies of this resolution to the Pickaway County EMA.
