

**Resolution 24-2015**

**A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR/VILLAGE ADMINISTRATOR OF THE VILLAGE OF COMMERCIAL POINT TO ENTER INTO A THREE YEAR CONTRACT FOR 2016, 2017 AND 2018 WITH RUMPKE FOR GARBAGE PICK UP IN THE VILLAGE OF COMMERCIAL POINT AND TO INCREASE THE RATES CHARGED TO VILLAGE RESIDENTS AND DECLARING AN EMERGENCY.**

WHEREAS, The Mayor/Village Administrator is authorized to enter into contracts on behalf of the Village; and

WHEREAS, council has determined that it is necessary to contract for garbage pick-up within the Village of Commercial Point; and,

WHEREAS, the fees being charged by Rumpke amount to more than the fees being charged to the Village residents.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. The Village Administrator is hereby authorized and directed to enter into a three year contract for 2016, 2017 and 2018 with Rumpke for curbside garbage pick-up.

Section 2. The rates charged for garbage/recycle pick up service to all Village residents except senior citizens shall be \$ 12.40 a month. The rates charged for garbage pick-up service to senior citizens within the Village shall be \$ 11.15 a month.

Section 3. Council declares this Resolution to be an emergency for the reason that garbage pick up can continue uninterrupted within the Village of Commercial Point. Accordingly, this Resolution shall become effective upon passage.
