

ORDINANCE 2012-12

AN ORDINANCE TO PROVIDE FOR ADJUSTMENTS OF THE ANNUAL BUDGET FOR THE FISCAL YEAR 2012 AND TO REALIGN MONIES WITHIN THE GENERAL FUND FROM ACCOUNT 1000-910-910 (TRANSFERS OUT) TO ACCOUNT 1000-715-341 (ACCOUNTING AND LEGAL FEES).

WHEREAS, on March 19, 2012 Council adopted Resolution No. 05-2012 approving the municipal budget for fiscal year beginning January 1, 2012 and ending December 31, 2012; and

WHEREAS, monies appropriated to the General Fund Accounting and Legal Fees Account (1000-715-341) are less than what is needed for the current and remaining yearly legal services fees for the Village; and

WHEREAS, monies appropriated to the General Fund Transfers Out Account (1000-910-910) are more than what is needed; and

WHEREAS, additional monies are needed for the 2012 current and future legal services fees for the Village; and

WHEREAS, Council desires to adjust the annual budget for fiscal year 2012 and to transfer monies within the General Fund from the Transfers Out Account (1000-910-910) to the Accounting and Legal Fees Account (1000-715-341).

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING, THAT:

Section 1. Monies in the amount of Thirty Thousand Dollars (\$30,000.00) shall hereby be transferred within the General Fund of the Village of Commercial Point from Account Number 1000-910-910 (Transfers Out) to Account Number 1000-715-341 (Accounting and Legal Fees).

Section 2. This Ordinance shall take effect immediately upon passage.
