

ORDINANCE NO. 2017-12

AN ORDINANCE ACCEPTING THE BID OF KIRK BROTHERS COMPANY, INC. FOR THE VILLAGE OF COMMERCIAL POINT DIGESTION IMPROVEMENT, AND AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR AND/OR MAYOR OF THE VILLAGE OF COMMERCIAL POINT TO ENTER INTO A CONTRACT WITH SAME, AND DECLARING IT AN EMERGENCY.

WHEREAS, pursuant to prior Ordinance, advertisement for bids for the Digestion Improvements occurred; and

WHEREAS, said bids were publically open and read on May 9, 2017; and,

WHEREAS, the lowest bid was received from Kirk Brothers Company, Inc.; and,

WHEREAS, the Village Engineer, who states that the company is a responsible bidder capable and qualified to perform the work, and that its bid was in compliance with all bid, contract and legal requirements, now recommends that the Contract be awarded.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Commercial Point, Pickaway County, State of Ohio:

SECTION 1: The bid of Kirk Brothers Company Inc. is hereby accepted.

SECTION 2: The Village Mayor and/or Village Administrator are hereby authorized to enter into a contract with Kirk Brothers Company Inc. in accordance with the specifications of the Village Engineer, the bid and contract documents.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare of the inhabitants of the Village of Commercial Point because timely award and start of the project are needed to meet financing conditions. Wherefore, this Ordinance shall take effect and be in force from and immediately upon passage.






