

ORDINANCE 2017-17

AN ORDINANCE SETTING THE COUNCIL MEETING SCHEDULE FOR THE VILLAGE OF COMMERCIAL POINT FOR YEAR 2018

WHEREAS, the Village of Commercial Point is a municipal corporation and duly organized and existing under the Ohio Revised Code; and

WHEREAS, the Council of the Village of Commercial Point finds that in conformance with ORC section 731.46, the governing body shall by ordinance set the time and place for holding its regular meeting which shall be held at least once each month ;and

WHEREAS, the Administration of the Village of Commercial Point finds it necessary to hold two regular meetings a month.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Commercial Point, Pickaway County, Ohio, as follows:

SECTION I: Council will meet twice a month for regular council meetings at the Village of Commercial Point Municipal Office located at 10 W. Scioto St., Commercial Point, Ohio.

SECTION II: The Council Meetings will start at 7:00 p.m. and open to the public.


