

RESOLUTION 10-2015

A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE GENERAL FUND FROM THE TRANSFERS OUT FUND 1000-910-910 AND TRANSFER SAID MONIES TO THE OTHER CONTRACTUAL SERVICES FUND 1000-110-399.

WHEREAS, Council is authorized to create, appropriate, and transfer funds within the General Fund of the Village of Commercial Point; and

WHEREAS, Council has agreed to allow the Mayor and/or Village Administrator to enter a contract with Pickaway County Sheriff from June 1, 2015 – August 29, 2015; and

WHEREAS, monies appropriated to the Transfers Out Fund were more than needed; and

WHEREAS, monies appropriated to the Other Contractual Services Fund were less than needed; and

WHEREAS, on May 13, 2015 the Fiscal Officer transferred monies within the General Fund to issue a purchase order to the Pickaway County Sheriff; and

WHEREAS, the Council of the Village of Commercial Point desires to ratify the action of the Village Fiscal Officer.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. Council hereby ratifies the action taken by the Village Fiscal Officer on May 13, 2015 as further set forth in Section 2 below.

Section 2. Monies in the amount of Ten Thousand Dollars (\$10,000.00) shall hereby be transferred within the General Fund of the Village of Commercial Point from Account Number 1000-910-910 Transfers Out Account to Account Number 1000-110-399 Other Contractual Services Account.

Section 3. It is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Commercial Point which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4. This Resolution shall take effect and be in force from and after the earliest date allowed by law.


