

RESOLUTION NO. 25-2015

**A RESOLUTION APPROVING THE DONATION OF A MOTOR VEHICLE THAT IS UNFIT FOR PUBLIC USE TO THE SCIOTO TOWNSHIP FIRE DEPARTMENT.**

**WHEREAS**, the Village of Commercial Point, Ohio is a statutory Village located in Pickaway County, Ohio; and

**WHEREAS**, The Village Police Department is the owner of a 2003 Dodge Durango, Vehicle Identification Number 1D4HS38N93F548839; and

**WHEREAS**, the Police Department has determined that the vehicle is unfit for public use and that the property has no value; and

**WHEREAS**, the Scioto Township Fire Department is in need of a salvage vehicle for training purposes and they have agreed to include the Village of Commercial Point Police Department in that training.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, OHIO THAT:**

**SECTION I:** The 2003 Dodge Durango, Vehicle Identification Number 1D4HS38N93F548839 is unfit for public use and that the property has no value.

**SECTION II:** The Mayor shall execute all paperwork necessary to donate the vehicle to the Scioto Township Fire Department for training.

**SECTION III:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that result in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION IV:** This Resolution shall take effect and be in force from and after the earliest date allowed by law.
