

RESOLUTION 12-2017

A RESOLUTION TO RATIFY THE REALIGNMENT OF MONIES WITHIN THE SEWER FUND FROM THE CAPITAL OUTLAY ACCOUNT 5201-549-590 AND TRANSFER SAID MONIES TO THE OTHER PERSONNEL SERVICES VILLAGE ADMINISTRATOR ACCOUNT 5201-549-130-1030.

WHEREAS, Council is authorized to create, appropriate, and transfer funds within the Sewer Fund of the Village of Commercial Point; and

WHEREAS, Council has agreed to increase the Village Administrator's pay; and

WHEREAS, the Village Administrator position will be working on projects for our Utility Department; and

WHEREAS, monies appropriated to the Capital Outlay Account were more than needed; and

WHEREAS, monies appropriated to the Other Personnel Services Engineer Account were less than needed.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF COMMERCIAL POINT, COUNTY OF PICKAWAY, STATE OF OHIO, A MAJORITY OF ITS MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. Council hereby ratifies the action taken by the Fiscal Officer on March 9, 2017 as further set forth in Section 2 below.

Section 2. Monies in the amount of Six Thousand Seven Hundred Dollars (\$ 6,700.00) shall hereby be transferred within the Sewer Fund of the Village of Commercial Point from Account Number 5201-549-590 Capital Outlay Account to Account Number 5201-549-130-1030 Other Personnel Services Administrator.

Section 3. It is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Commercial Point which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4. This Resolution shall take effect and be in force from and after the earliest date allowed by law.
